RULES & REGULATIONS:

DESCRIPTION: An Art and crafts festival featuring local and national artists. The festival also offers free activities for children, a classic car show, The Grassroots Music Festival and the Toy Box Trot.

DATE/HOURS: September 15, 2018, 9 a.m. – 5:00 p.m. and September 16, 2018, 11 a.m. – 5:00 p.m.

LOCATION: Glover Park on the Marietta Square in historic downtown Marietta Georgia. Marietta is located just 15 miles northwest of Atlanta and 5 miles off I75 in Cobb County.

ACCEPTED CATEGORIES: Art, crafts and market goods (soaps, lotions, candles, prepackaged dips etc.). A panel of experts will review all applications.

APPLICATION DEADLINE: June 21, 2018 (mail-in and Zapplication)

FEES: Jury/Application: \$25.00, Booth Space: 10x10 - \$165.00 or 10X20 - \$330.00

Submit a separate check for the jury fee and booth space. Zapplication payment is due July 31, 2018.

The jury check will be deposited when the application is processed, the booth check (if accepted) will be deposited after the jury process is complete (around July 17th). *Applications will NOT be processed without full payment and photos.*

ACCEPTANCE NOTIFICATION: Acceptance notification will be sent via email by July 17, 2018. Booth location & set up information will be sent by September 6, 2018. Make sure to include the SASE (self-addressed stamp envelope).

PHOTOS: Five (4X6 photos ONLY), 3 - actual work, 1 – workshop/studio, 1 – outdoor booth display. They should be high quality and current images of the artwork and booth display

BOOTH SPACE: Artists must furnish their own tent, display tables & skirting. All displays must be designed, constructed and operated in good taste. Displays, sales and promotional activities must be confined to artist's assigned space. Tent weighting is recommended-all booths are located on the street.

SET UP: Saturday, September 15th, 5:00 a.m. – 8:30 a.m.

PARKING: Parking is available and all participants must park in the designated parking area. Vehicles are NOT permitted in the festival area during festival hours. Failure to comply could result in removal from the show and future shows. ALL VEHICLES MUST BE REMOVED FROM THE FESTIVAL AREA 30 minutes before the festival begins

TEAR DOWN: Teardown may begin at 5:00 p.m.; however, vehicles are NOT permitted in the festival area until 5:30 p.m. All booth items and vehicles must be out of the festival site area by 7:00 p.m. on Sunday. The streets will reopen at 7:00 p.m.

DATES: Deadline – June 21, 2018

Notification – July 17, 2018

Zapplication payment – July 31, 2018

Set up details/booth space – September 6, 2018

TAXES: The exhibitor is responsible for collecting and paying all Georgia sales tax and any additional applicable city, county and federal taxes. Sales tax in Cobb County is 6%.

WAITLIST: Those not accepted into the show (because of limited booth spaces) will be placed on a waitlist and will be notified as spaces become available. Checks will only be deposited if space is found.

NO REFUNDS: The show is a rain or shine event. Refunds will not be issued once acceptance notices have been sent.
